Codes with a *NOTE: CMS has expanded packaging for CY 2014. In addition to contrast agents and diagnotic radiopharmaceuticals being packaged and paid as part of the 2013 procedure payment rate, effective with claims date of service January 1, 2014, the rates for services that would also include a stress agent or when the stress test is performed on the same date of service as the MPI or Cardiac MRI, or Echo study (or any other procedure that includes a stress test) the cost of the stress test is included in the procedure payment. In other words, the stress test is not separately paid.
